Invitation for Tenders

- 1) The Government of the United Republic of Tanzania has set aside funds for the operation of the **Kondo Town Council** during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Construction of Mongoroma, Bolisa Chandimo and Mulua Water Supply Scheme .**
- 2) The **Kondo Town Council** now invites sealed Tenders from eligible **Civil Works (national)** contractors registered or capable of being registered in **Class V and above** for carrying out the **Construction of Mongoroma, Bolisa Chandimo and Mulua Water Supply Scheme .**
- 3) Tendering will be conducted through the **National Competitive Bidding** specified in the **Procurement Regulations, 2013 – Government Notice No.446** and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.

- 4) Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board **Kondoa Town Council, P.O.Box 711, Kondoa**, from 08:00am – 03:30pm, on Mondays to Fridays inclusive except on public holidays.
- 5) A complete set of Tendering Document(s) in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of Tanzania shillings **One Hundred Thousands only (Tshs. 100,000.00)** . Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **the Town Director, Kondoa Town Council, P.O. Box 711, KONDOA**.
- 6) All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.
- 7) All Tenders in one original plus three copies, properly filled in, and enclosed in plain envelopes must be delivered at or before 10:00 am on 25 June 2018 to the **Secretary of Tender Board at Kondoa Town Council Head Office**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Council Conference Hall**.
- 8) All Bids shall be addressed to the following address: **The Secretary, Tender Board, Kondoa Town Council, P.O. Box 711, Kondoa**. Marked: **"DO NOT OPEN BEFORE 10:00 am on 25th June 2018**.
- 9) Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances
